This years convention will held in the auditorium of the Bergenfield High School at the corner of S. Prospect Ave. & West Clinton Ave. beginning at 8:00 p.m.. Refreshments after the convention will be served at the Prospect Fire Co.#1 firehouse located across the street from the High School.

Nominations are still open for the positions of 2nd. Vice President and Assistant Secretary. Nominations are being accepted until the April meeting at which time nominations will be closed. Consider running for one of these positions in your Association.

The Bergenfield Convention Committee is reaching out to our brethren by asking you to do several things. Second, consider selling ads for this years journal. For every \$1,000.00 in advertising that your Department generates, your Fire Department will receive one free night of training at the Bergenfield Fire Training Center.

Third, any of your members that take an ad for their own business will be highlighted as a volunteer firefighter. Please make sure that you have them note this when they submit their ads.

Fourth, please sign up for the Truck Judging Competition, Firefighting Strategy & Tactics exam competition, and our Strongman Antique Fire Apparatus Truck Pull competition.

Lastly we invite you to join us for this years convention on June 9th 2006 in Bergenfield.

Since this year there is only a Convention meeting the Bergenfield Fire Dept have planned a few activities spanning several days to make this event special.

May 31—Strategy and Tactics Exam

Three firefighters from each Department compete as individuals and as a team in a written examination based on firefighting Strategy & Tactics. Department s may enter multiple teams. Individuals and teams can earn points towards the BEST OVERALL TROPHY. Competition points will be awarded only for the single highest scoring team and single highest scoring individual.

The written examination will be 100 question multiple choice test based on questions from the following firematic books: Fire Officer's Handbook of Tactics (3rd edition) by John Norman, Responding to Routine Emergencies by Frank Montagna, Fireground Strategies by Anthony Avillo, Fireground Size-Up by Michael Terpak.

Trophies will be awarded for 1st, 2nd, and 3rd place for individuals and for team competition between fire departments. Winners will also receive gift certificates from Fire Engineering Books & Videos. The exam will be administered on Wednesday, May 31, 2006 at the Bergen County Fire Academy 281 Campgaw Road in Mahwah, New Jersey. The exam will begin promptly at 7:30 p.m. NO one will be admitted late.

June 4—Apparatus Judging

Held at the Prospect Fire Company #1 Firehouse on West Clinton Ave. Starting at 09:00 hr.

June 9—Antique Apparatus Truck Pull

Starting at 5p.m. - 7:45 p.m. This is a timed event featuring Strong Men Teams of 8 to pull an antique fire truck a distance of 50 yards using rope.


