We mourn the loss of Ex-Chief Stephen Dembski of the Ridgefield Park Fire Dept. Dembski "didn't feel well" and collapsed after fighting a mutual aid alarm while assisting the Bogota FD. Medical teams including President Robert Kirsch worked feverishly to revive Dembski but to no avail. We as fellow firefighters lost a dedicated brother in the line of duty.

I experienced the sad honor of being part of the "sea of blue"; hundreds of firefighters from all over that came to offer condolences to his wife, children and family. It seems appropriate to quote the closing line from the Fireman's Prayer, "...please bless with your protecting hand my children and my Wife."

We also experience the concern of Garfield firefighter Radoslaw Polanski who was seriously injured while responding to an alarm of fire. Sure, there are circumstances involved with this accident but the bottom line is a dedicated volunteer was seriously injured while responding to a call for help. Lets offer our prayers for his fast recovery and continue to support his family and members of the Garfield Fire Dept.

These recent events emphasize the need for us to look out for each other and help whenever and wherever we can. As I mentioned last issue accidents can happen to anyone and we all have families that would have to deal with our recovery if we ever got hurt or worse yet, not return home. So let's think of them in whatever we do.

Important Benefit Update

The lottery starts on October 1, 2007. SO FAR, THE RETURNS HAVE BEEN VERY POOR. Out of 132 sent we've only received returns from 19 NJ member companies and 1 NY member company. Only 194 calendars sold so far. This calendar lottery is our main source of income for our Death Benefit. The Death Benefit is now \$1,000.00 and we pay 7 to 10 claims a year. At this rate, we will not have enough funds to keep this going for too long. When we start dipping into reserves to make prize payments and Benefit payments, the whole program will be gone. If all member companies send in \$50.00 to cover the calendars sent them we would be starting out with \$6,600.00 in the prize pool. Unless we have more participation, we may have to discontinue future calendar sales. PLEASE HELP NOW!

2007 Convention Service Awards



UNIT CITATION AWARD—DUMONT FIRE DEPT. Deputy Chief Daniel Molinaro, Captain James Molinaro, Firefighters Peter Daniele, James McGloin, Robert Stevens.

On June 21, 2006 the Dumont Fire Dept. received numerous calls of a working fire. Upon arrival Chief Molinaro was informed that three occupants were in the building. Without regard for his own safety and without protective equipment he entered the structure and attempted a quick search of the apartment.

Deputy Chief Molinaro located the first victim and brought her to safety. He re-entered the apartment but was pushed back by the fire and heavy smoke just as the first arriving engine was pulling up to the scene. He

advised the members of Engine Co 3 that two residents were still inside. At the same time Captain James Molinaro, Firefighters James McGloin and Peter Daniele entered the structure to complete the primary search. Firefighters McGloin and Daniele located the second victim who was unconscious and was brought out to safety by Firefighter McGloin. At the same time, Captain James Molinaro and Firefighter Daniele continued their search.

Firefighter Daniele located the third victim in the front bedroom, unconscious and not breathing. Daniele then broke out the front window and returned to the victim, loosing his face mask in the process. Daniele was able to hand the victim to the police who immediately began life saving measures and were able to get the victim breathing again. After passing out the victim, Daniele also bailed out the front window due to loosing his mask. At the same time Firefighter Robert Stevens entered with an attack line and along with Capt. Molinaro was able to knock down the fire in the rear bedroom and hallway.



2007 PRESIDENTIAL VALOR CITATION—NANCY, K. NAYLIS

On Friday Sept. 29 2006 after a general business meeting of the NJNY-VFA Pres. Robert E. Kirsch was enjoying dinner when a large piece of food became lodged in his throat. He had difficulty breathing and could not speak. Bergenfield Firefighter Nancy Naylis noticed his difficulty and quickly moved behind the victim preparing to perform the Heimlich maneuver, all the time asking him if he was OK, if he could breath or speak. Once Pres Kirsch indicated no she immediately applied the maneuver with one quick and sudden inward and upward thrust. With this move she was able to dislodge the obstruction from his throat. After being called be a fellow member who witnessed the incident members of the

Leonia Fire Dept came running into the room to assist. Thankfully President Kirsch was able to clear the obstruction with the assistance of Ms. Naylis. Thanks to Nancy Naylis for her quick response in using her expertise in saving the life of a fellow firefighter.



2007 RUDY APPELD SERVICE AWARD—MILTON R. COLE

Milton R. Cole was admitted to the Hook & Ladder Co of the Westwood Fire Dept in April 1956 after serving 3 years 11 mos. On the Ridgefield Park FD. and became an exempt member in 1964. During his tenure Milt served the department in various positions: Secretary 1963—1967; Vice President 1965, 1967, 1983; President 1968, 1969, 1984, 1985; Lieutenant 1965, 1967; Captain 1968, 1969; Captain of Emergency Truck 1971; 2nd. Asst. Chief 1972; 1st. Asst. Chief 1973; Chief of Department 1974; Department Secretary 1977-1986. Milt also served as Secretary of the New Jersey & New York Volunteer Firemen's Assn. for many years and also served numerous offices of the Association: 2nd. Vice President

1988—1990; 1st. Vice President 1990—1992; President 1992—1994. Milt is currently Chairman of the 100th Anniversary Committee of the Assn. He served as Exec. Committeeman of the NJ Sate Assn from 1993-2003. Milt is also Past President of the Bergen County Firemen's Home Assn. Hats off to Milt who remains very active in all the associations in which he has contributed 55 years of dedicated service and still counting.


