2009 Convention Service Award Winners



Presidential Lifesaving Award Angelica Mercado

On November 20, 2008 a gasoline tanker carrying over 8,000 gallons of gasoline rolled over on the exit ramp of the NJ Turnpike Exit 16. Within minutes the truck exploded. The driver of the truck, Rajinder Singh of Queens managed to get himself out of the truck and onto the roadway. Angelica Mercado, a student nurse with Holy Name Hospital was on her way to work the night shift. When she saw the tanker explode, she immediately pulled over and could see Singh was engulfed in flames. Without hesitation, she ran toward him, removing her coat and used it to smother the flames on Singh. Once extinguished she placed him in her car, driving him to the nearest hospital, University Hospital in Newark.

Later he was transferred to the burn unit at St Barnabus Hospital where he was described as "critical but stable condition" with second and third degree burns over 40 percent of his body. Angelica Mercado's intervention was heroic in such a dangerous situation, one that many people would run from, not toward. For such a young woman to have disregarded her own safety to help another is extraordinary. The NJ & NY Volunteer Firemen's Assn is proud to present the 2009 Presidential Lifesaving Award to Angelica Mercado.



2009 Citizens Award The Gardner Family

John & Kyra Gardner, parents of three teenage children, lived in a cedar-sided home in Ramsey NJ. Although the children poked fun at the parents ordering monthly fire drills in their own home, they practiced again and again for the day they hoped would never come. Monthly drills, escape plans, smoke alarm batteries - all things that people know they should do but tend to overlook.. All that practice paid off the one morning in March as the Gardner family woke to the sound of smoke detectors. Fire gutted their DeBaun Ave home in a pre-dawn fire where the Gardners narrowly escaped with their lives. "Fire" Kyra yelled, just as they rehearsed. Immediately the couples three children took their places in their door-

ways on the second floor of their home. Kyra grabbed 18-year old Alex, who has autism, and John went for Nicholas (17) and McKenzie (14). As one unit, John led the way with all three children in between and Kyra following up in the rear. John slipped down the stairs as they reached the front door and found the door sealed shut. The Gardners now put their back-up plan into effect and headed for the back door. As the flames grew bigger, windows shattered and heavy smoke filled the air, they rushed outside without anything on their feet and raced across the street where neighbors called 911. The entire evacuation took about 2 1/2 minutes. Fire trucks lined the usually quite street where crowds gathered to watch firefighters battle the blaze. Ramsey Chief Mike Scalione said upon arrival the house was fully involved and it took firefighters 30 minutes to get the fire under control. Although all occupants escaped, unfortunately the family's three dogs perished in the fire. Regular fire drills and working smoke detectors were key to saving the family's lives. 2009 Unit Citation Award—Leonia Fire Dept Capt. Robert Chace, Ex-Chief Steven Oxnard, Dep Chief Troy Wright

On the morning of July 23, 2008 a call came in as a report of smoke in the neighborhood. Misty fog helped to make poor visibility and made it difficult to trace the fire. As apparatus arrived they found the 2nd. Floor engulfed in fire. Chief Ron Chace called a 2nd alarm mutual aid. Dep Chief Roy Wright and Capt Robert Chace began primary search without the benefit of a hose line. They were met with high heat and zero visibility, putting them at risk. They found the main

staircase at the rear of the house and ascended towards the third bedroom which was now fully involved. Ex-Chief Oxnard also began a secondary search of the living room. As conditions quickly worsened Oxnard found an unconscious male, located between a table and chair. He called for assistance and was joined by Dep Chief Wright and Capt Chace. Once they were out of the house CPR was begun immediately. Despite the efforts of firefighters and EMTs, the victim later succumbed to his injuries. On October 1 2008 Ladder Co 1 responded to smoke coming from a first floor apartment. Ladder #1 was under command of Lt. Walker. Walker and Firefighter Reinhart entered the building. Once inside they forced entry and found a working fire involving the living room and its contents. Firefighter used a water can to hold the fire in check while Lt. Walker conducted a primary search, discovering a female occupant sleeping. Walker and Reinhart were able to remove the oc-

cupant where EMS evaluated her condition. The efficient manner and rapid precision on the part of these fire-fighters helped to avoid a potential loss of life or serious injury.
