


JARED CALVIN LLOYD - A HERO AMONG US LODD MARCH 23, 2021

A New York Community is rallying around the family of a firefighter who tragically died while putting out a fire at a nursing home and was attempting to rescue residents of the home.

Spring Valley Volunteer Firefighter Jared Lloyd, 35, died Tuesday in the massive blaze at Evergreen Court Home for Adults, according to flagship station WABC.

The father of two's death came just one day before his son Logan's 6th birthday on Wednesday, the outlet reported.



According to WABC, there were 112 people inside the assisted living facility when the fire broke out around 1 a.m.
